The application seeks to create two new refuse and recycling stores within the recently completed Regent's Gate residential complex. This is due to the difficulty with which the refuse collectors can currently access the existing bin store (access often blocked by parked cars), as well as the inconvenience the current bin store location poses for the residents. The issue has become apparent now that the building is occupied, and the new proposals seeks to address this issue, providing a new bin store which is easily accessed by both refuse collectors and residents and will not be obstructed by resident's vehicles.

The bin stores proposed will provide refuse and recycling storage which exceed Camden's requirements. The proposed housing of the bins will be ventilated, fully lit, and secured. The flat roofs proposed are green roofing to provide a more pleasant outlook from the flats above.
