- 4 - Lime (x1) Reduce crown by 20-25% (reduce height by 3m and width by 1.5-2m). Retain furnishing growth. Remove all branches up to a height of 6m. Reason: Tree is overgrown.
- 5 - Sycamore (x1) Reduce crown back to previous points of reduction. (Reduce height by 4-5m and width by 2-3m all around). Reason: Tree is overgrown.
