The deck and balustrade, having already been constructed, was subject to an enforcement notice on the grounds of overlooking to an adjacent property at the rear of the site. The enforcement officer, Ms Ryan, stated that some appropriate screening would need to be installed and that the whole construction of the deck, balustrade and screen would require retrospective planning approval. Ms Ryan attended site on 12th May 2016 to inspect a sample of the proposed screen comprising camouflage netting on a 1.8m high frame, which she approved verbally at the time. Subsequently, in a telephone call on 24th May 2016, Ms Ryan also confirmed that due to the nature of the proposals, a design and Access Statement would not need to be submitted with the application.
