DECISION

Proposal:
Erection of two front dormers and creation of a roof terrace with timber screens over rear wing.
Drawing Nos: location plan, A-110-P4, A-111-P2, A-112-P2, A-220-P7, A-221-P4 and A-222-P4.

The Council has considered your application and decided to grant permission subject to the following condition(s):

Condition(s) and Reason(s):

- 1 The development hereby permitted must be begun not later than the end of three years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).



- 2 All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy CS14 of the London Borough of Camden Local Development Framework Core Strategy and policy DP24 of the London Borough of Camden Local Development Framework Development Policies.

- 3 The development hereby permitted shall be carried out in accordance with the following approved plans- Site location plan, location plan, A-110-P4, A-111-P2, A-112-P2, A-220-P7, A-221-P4 and A-222-P4.

Reason: For the avoidance of doubt and in the interest of proper planning.

- 4 The development shall not commence until details of two 1.8m high privacy screens facing the sides of 83 and 87 Ravenshaw Street have been submitted and approved in writing by the Council. The screens shall be permanently retained thereafter.

Reason: In order to prevent unreasonable overlooking of neighbouring premises in accordance with the requirements of policy CS5 of the London Borough of Camden Local Development Framework Core Strategy and policy DP26 of the London Borough of Camden Local Development Framework Development Policies.

- 5 Details of the proposed balustrades, upstands and planters on all sides of the roof terrace and details of the proposed means of access from loft to the roof terrace shall be submitted to and approved in writing by the local planning authority before the relevant part of the work is begun.

The relevant part of the works shall be carried out in accordance with the details thus approved.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy CS14 of the London Borough of Camden Local Development Framework Core Strategy and policy DP24 of the London Borough of Camden Local Development Framework Development Policies.

Informative(s):

- 1 Reason for granting permission

The front dormers will be appropriately sized, located and designed to match others in the street, notably two that were granted permission in 2006 at no.57; they are modest traditional designed dormers and will comply with current design guidance. The proposed design and materials of the dormers are sympathetic to

the host building and streetscene.

The proposed roof terrace is set away from the rear edge and has a metal balustrade here to reduce its visual impact. Although the solid balustrades and planters are somewhat bulky in appearance, they are necessary to reduce overlooking. It is considered that the overall impact on the host property is considered acceptable in design and bulk terms, as this property backs onto the railway line, has limited visibility in the public realm, and there are a variety of alterations and extensions apparent along the rear of this terrace of properties. However more details are required for the perimeter structures to ensure their acceptability in terms of detailed design and materials. Additional details are required by condition to understand how access will be achieved to the proposed roof terrace as this is not shown on the submitted plans.

The terrace will not cause any overlooking to neighbours at nos 83 and 87, provided that suitably designed and sized privacy screens are installed on both sides facing these properties due to the proximity of rear windows.

The site's planning and appeal history has been taken into account when coming to this decision. No objections were received to the application.

As such, the proposed development is in general accordance with policies CS5 and CS14 of the London Borough of Camden Local Development Framework Core Strategy, and policies DP24 and DP26 of the London Borough of Camden Local Development Framework Development Policies. The proposed development also accords with policies 7.4, 7.6 and 7.8 of the London Plan 2016; and paragraphs 14, 17, 56-66 and 126-141 of the National Planning Policy Framework.


- 2 Your proposals may be subject to control under the Building Regulations and/or the London Buildings Acts which cover aspects including fire and emergency escape, access and facilities for people with disabilities and sound insulation between dwellings. - 3 Noise from demolition and construction works is subject to control under the Control of Pollution Act 1974. You must carry out any building works that can be heard at the boundary of the site only between 08.00 and 18.00 hours Monday to Friday and 08.00 to 13.00 on Saturday and not at all on Sundays and Public Holidays. You are advised to consult the Council's Compliance and Enforcement team [Regulatory Services], Camden Town Hall, Argyle Street, WC1H 8EQ (Tel.
