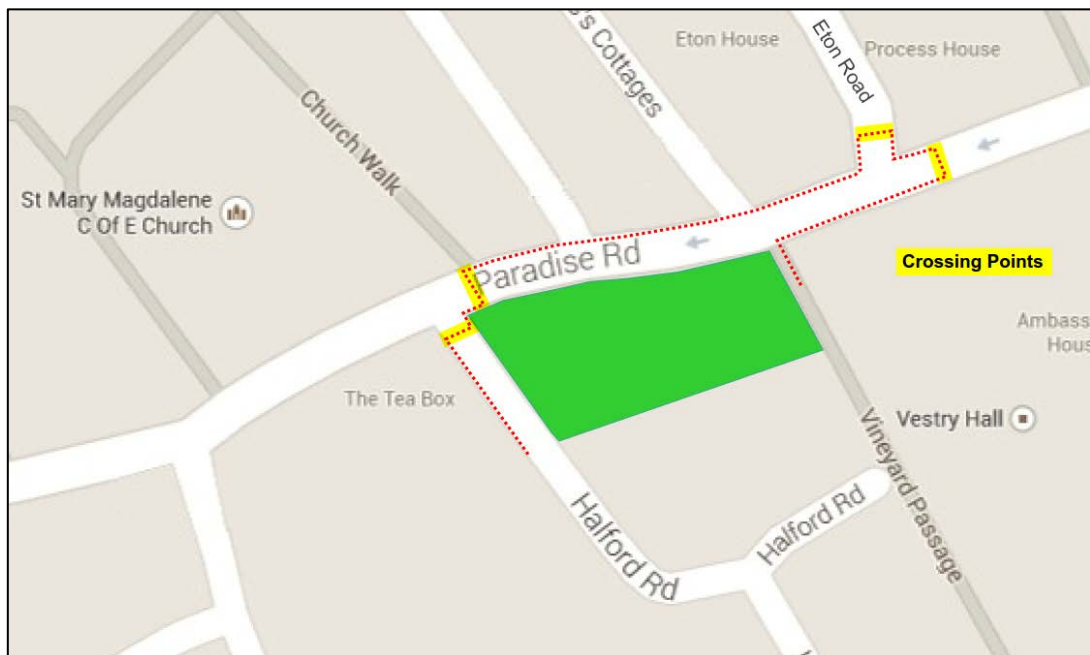

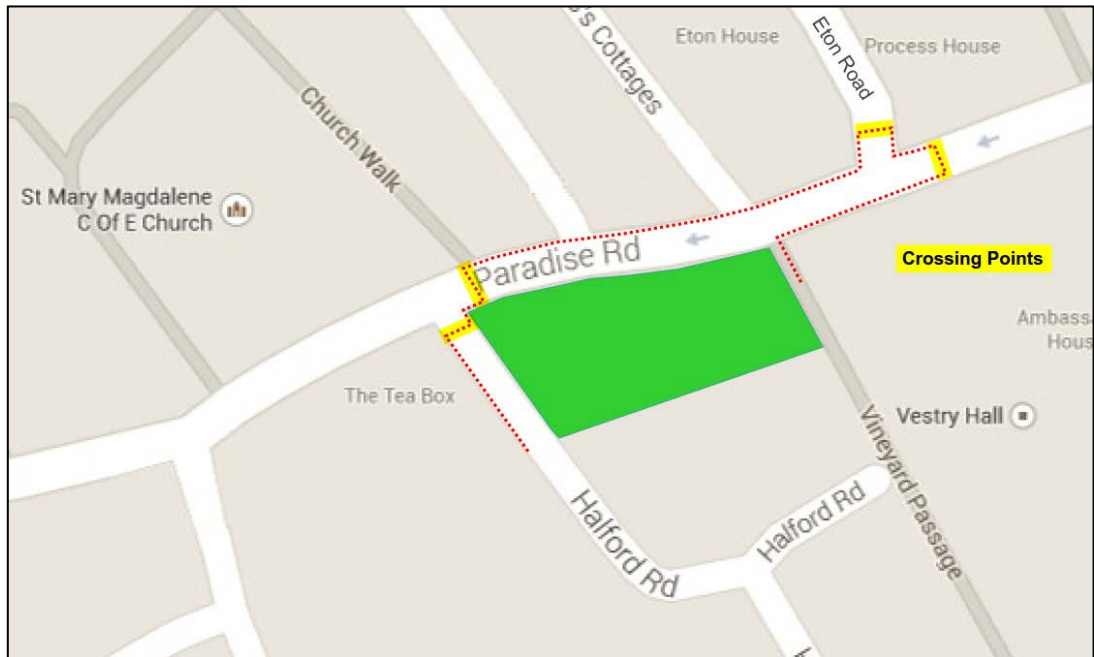
The alternative pedestrian route is shown opposite and direction signage will be displayed.
