Rear Garden:

Acer Griseum: Remove dead stubs and carry out remedial pruning. If upon climbing the tree is assessed to be unfit for retention; fell to ground level.

Reason - This tree appears to have suffered some crown dieback. It still has merit however for its aesthetic value.

Hoheria Stardust: Approximately 4.50-5.00m. Twin-stemmed. Reduce crown by 20-25% and carry out necessary shaping in order to form a more compact shrub whilst preserving screen, natural characteristics and aesthetic value.
