T2. Birch Tree- Reduce back to previous pruning positions. Reduce approx 1.5- 2m from the height. Remove approx 1m off the sides to reshape. Light thin.

T3. Birch Tree- Reduce back to previous pruning positions. Remove approx 2m off the height. Reduce sides by approx 1m to reshape. Light thin.

T4. Prunus Amanagowa- Remove deadwood.

Reasons for work- Routine maintenance of trees.
