Hello,

Having read the Design and Access statement in this planning application I have copied the below text.

Notemachine in their overall duty of care to the public have at this site installed a NCR - ATM these machines can have a Pin Shields added to prevent Pin Fraud.

Notemachine have taken on board security recommendations and will incorporate in their installation the use of mirrors / Polished surfaces to improve surveillance for the user, these are placed as to avoid reflection of the key pad numbers.

Notemachine will install a defensible space (Ground Markings) in front of the ATM to indicate only one ATM user at a time, subject to pavement width, council recommendation and seek retrospective local authority approval.

Notemachine will in their design give consideration to additional anchoring systems i.e. anti-ram bollards subject to Local authority planning consent – conditioning

I don't know if these security measures will be fitted. I would like clarification as to whether these security features will be fitted or not. I would recommend that they are.
