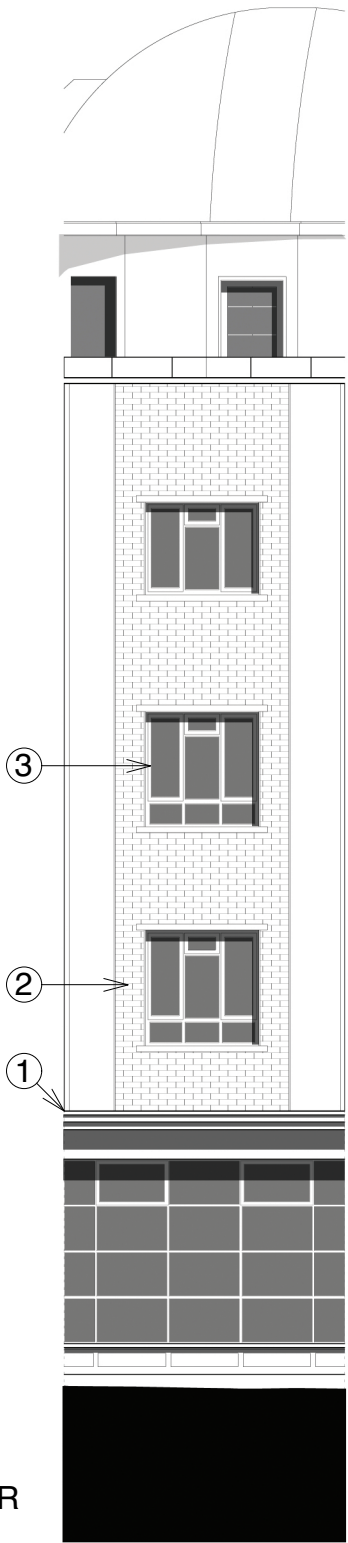
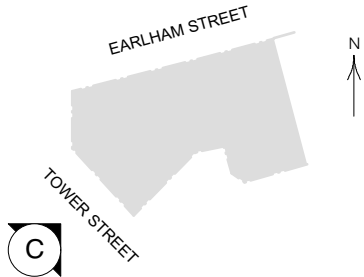


PROPOSED MATERIALS:

STREET AS PROPOSED

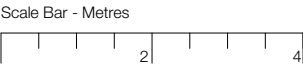
