Group of Damson: Approximately 5.00m. Reduce by 25%. Reduce by 25%. Reduce back over neighbouring property by 30% to control encroachment.  
Privet Bush: Located rear left hand boundary. Trim to tidy, approximately 20%.  
Mixed Shrub Group: Including pyracantha. Trim to tidy and form a more compact shrubbery.  
Reasons - General maintenance and to abate nuisance.
