The Pub - The Leighton - and its garden is public amenity which I am pleased too see is identified as such in the new local plan. Our community often used to sit in the pub garden to enjoy a evening drink before the garden was boarded up from the street by the developer. The garden should be reopened asap.</p> <p>These mid 19th century streets were laid out according to certain criteria whereby each terrace is separated from those at right angles to it. The Leighton pub forms the end of terrace on Brecknock Road and No. 135 Torriano Avenue forms the end of terrace along Torriano Avenue. Both these building celebrate their importance by projecting forward from the main terraces and by being taller and more elaborately detailed. The proposed two new houses join the terraces together which defeats the purpose of the original architecture.</p> <p>Furthermore because of the traditional arrangement outlined above, the run of gardens behind the Brecknock Road terrace form a green corridor from Torriano Avenue to Leighton Grove. This run of gardens includes the pub garden.
