My client owns two terraced houses which are used as a single dwelling house to facilitate the access and care of his elderly mother who cannot access the first floor. My client has introduced 2 doors linking the two properties internally to allow access and supervision of his mother who cannot access the stairs. He is using the two properties as one linked family home and through this application is seeking to obtain confirmation that this use which has continued since March 2010 does not require a planning approval.
