To: contain spread and improve light, space and clearance all round: Reduce crown all round by 30-35% to previous reduction points, retain crown continuity. Thin and clean out crown, remove deadwood, weak and suppressed branches and suckers. Lift canopy all round by up to 2m. Balance crown
