As as professional record producer of  $40^+$  years experience, I am obliged to express my concern that the business of music recording conducted by AIR Studios will be severely harmed by the proposed building works planned by their neighbours. Any noise generated by the work will prevent recording even though the studio is more than sufficiently sound-proofed against normal disturbances caused by intrusive external sound.

AIR Studios is one of the few high-quality recording studios remaining in London, and it would be disastrous to lose it. Any disruption to its activities over even a short period of time would negatively affect its client base, who would inevitably and reluctantly have to relocate to other recording studios, possibly elsewhere in Europe. This would be likely to cause closure of the studios.

Hello Mr Tulloch,

It's clear form the proposed works which involved excavations will cause significant vibration and noise. There is no physical way to prevent this when engaging is such a project. The disruption to the studios will make them untenable in the high end environments they provide.

We as engineers are not going to book if there's any possibility of extraneous noise which would disrupt the recording / mix or mastering processes all of which require a controlled environment.

Compensation is also not an option, work will be taken elsewhere, it's likely to stay elsewhere, consistency is key to delivering a professional studio environment.

If you allow this to go ahead it will be the end for Air Studios - this will be a profound loss to the international music industry as its client base evidences.

Maybe the owners of the neighbouring property should buy a building that actually matches there needs in the first place? Food for thought...

Please don't let this go ahead - the music industry is on its knees already. Don't go down in history as the council that put the nail in our coffin.
