I'm incredibly concerned by the planning permission war occurring at the moment. Recording studios are not massive money making businesses, as evidenced by the fact that hundreds of the them disappeared over the last 15 years in London. Air is one of the last handful of classic studios, it is run by and employs talented and passionate people.

It's of absolute importance that the recording areas remain unsullied by noise pollution, some of the music recorded there is whisper quiet. Building work from next door would kill this business. I work long days (often 14 hours) in order to maximise productivity, any impediment to this would have an extreme impact on my work. If his building work goes ahead it will be the end of Air.

It was just brought to my attention that there has been a new planning application for basement adjacent to Air Studios.

Even though the plans have changed to some extent and one of the basements removed the proposed works are still posing a quite substantial threat to Air Studios next door, of which I am a regular customer so I am objecting to this new planning application as I objected to the last ones:

Excessive outside and structural noise and vibration, which would be inevitable in the proposed building works, cannot be tolerated in a studio environment as it does effect the recordings and would therefore mean that the studio would not be able to operate.

As a regular client of Air Studios, one of the few remaining studios of its kind in the world, I can assure you that this would be disastrous for the music industry in the UK and have serious knock on effects on music businesses in the UK. If the studio had to close for a longer time this might result in its closure, which would cause irreparable damage to the music industry, which is one of the UK's truly unique industries, which contribute greatly to UK GDP.

I implore you to reject the planning application or at least impose severe restrictions on building works (only to be carried out limited hours of the day with severe fines if they go over these hours).
