Proposal:

(TPO REF C1166) WITHIN GROUNDS: 1 x Holm Oak - Lift lower canopy up to 4m in height, thin crown by 15%

- 1 x Sycamore Remove epicormic growth by up to 5m, cut back branch to south of tree by 3m
- 1 x Plane Reduce limb overhanging neighbouring property by 3-4m
- 2 x Limes Remove epicormic growth up to a height of 5m
- 1 x Sycamore Remove lower branches overhanging neighbouring property
- 1 x Horse Chestnut Remove epicormic growth up to a height of 5m
- DD 1 x Fallen tree leaning on privet Remove DD

The Council has considered your application dated 20 April 2016 and decided to grant consent subject to the following condition(s):

Conditions and Reasons:

completed, whichever is the sooner.
