Installation of a 2 x 3-fold gate up to 2metres high (street gradient dependant and to be confirmed upon surveyors' visit), including a 1.65m extension of the right-handside wall when facing the house, at the driveway level in order to:

- 1- have a more secure home
- 2- prevent rubbish build up from road and passers by
- 3- reduce immediate noise pollution
- 4- have more privacy
- 5- prevent members of the public from parking in the driveway without permission as per attached pictures taken on 02 July 16.

The finish will be as per the attached picture of one of the panels that will make the 2 x 3 fold-gate. It is a high quality finish of which the steel frame colour shall match the cladding of the house facade. The wood's natural colour and the steel painted grey will constitute a contemporary finish that will match the neighbouring gates well (grey and washed bricks) or finished of the adjacent houses.

We opted to go for a light gate structure in order to lighten the gate impact and keep the openness through the lower walls on the side.
