1 Reasons for granting permission:

The materials proposed are considered to be of a high quality and appropriate in the context of the conservation area. The new timber doors, replacement timber sash windows, slate roof and iron balustrade would match the adjacent houses, which in themselves preserve and enhance the character and appearance of the host building and Hampstead Conservation Area. The details are considered sufficient to satisfy the requirements of the condition.

As such, the proposed development is in general accordance with policies CS5 and CS14 of the London Borough of Camden Local Development Framework Core Strategy, and policies DP24 and DP25 of the London Borough of Camden Local Development Framework Development Policies.
