We write in regard to the above applications following your emails of the 1st and 3rd of June 2016 to provide the additional information requested and to address the comments that have been received to date. For simplicity, I have set out my responses in below:

Additional Drawings

The following additional drawings have been prepared by Robert Myers Associates in response to your request:

622.02 (SC) 001 Section A-A

We have produced a section through the entrance of 6-10 Cambridge Terrace that specifically identifies the relationship between existing and proposed levels. The entrance steps remain unchanged and only at the foot of the existing stone steps do we start to see a minimal alteration to the levels, directing surface water run-off away from the public footpath. To confirm there is no alteration to 6-10 Cambridge Terrace entrance and our proposal is to clean and restore the existing stone where necessary.

622.02 (SC) 002 Elevation B-B LAYOUT

This drawing represents the East elevation inclusive of the proposed gate and wall mounting at 1:20 scale.

622.02 (SC) 003 Elevation A-A LAYOUT

This drawing represents the West elevation as viewed from the Outer Circle.

As outlined above, we have prepared additional information in response to comments that have been submitted to the Council during the determination of the above applications. The additional information is outlined below:
