1 Reasons for approval-

The landscaping details include a variety of tree planting, paving, biodiversity enhancements, green roofs, lighting, boundary fences, walls and railings, and highway surfacing improvements on Rowland Hill Street. A broad range of trees and plants in beds, raised planters and green roofs are proposed which are considered to enhance the biodiversity of the area.

The details are considered to be high quality and suitable for the site and they will contribute to the visual amenity, biodiversity and character of the area as well as enhancing the public realm.

The full impact of the proposed development has already been assessed. The proposed details would not have a harmful impact on the appearance of the host buildings and streetscene or on neighbouring amenity.

As such, the proposed details are in general accordance with policies CS14, CS15 of the London Borough of Camden Local Development Framework Core Strategy, and policy DP24 of the London Borough of Camden Local Development Framework Development Policies.

You are reminded that conditions 2 (design and materials), 3 (sample panels), 12 (PV panels), 13 (bird/bat boxes), 15 (green roofs), 18 (impact piling) of planning permission granted on 28/08/15 ref 2014/6449/P are outstanding and require details to be submitted and approved.
