## SUBMISSION OF DETAILS FOR PARTIAL DISCHARGE OF CONDITION 4A OF PLANNING PERMISSION REFERENCE 2014/4986/P (DETAILS OF WINDOWS AND FACING MATERIALS AND SAMPLES)

Fleetwood have prepared detailed plans, including sections of the mezzanine windows, the windows on the nose of the building, the strip windows on the central bay of the New Oxford Street elevation and the louvred cores on the same elevation, as required by Condition 4a of the above referenced planning permission.
