Hi Helen

I hope you are well.

I have been going through the application at 49 Swains Lane and unfortunately the council cannot support the application. The overall bulk scale and mass of both the first floor and rear and side dormer extension would lead to a visually incongruous addition to the host property which would have a negative effect on the surrounding Conservation area. Therefore the application is due to be refused.

Also I have received a number of objections from local residents and the local conservation area committee.

Going forward there are two options for you to discuss with your client, the first is proceed with the refusal and appeal the decision, whereas the other is to withdraw the application and re submit a scheme which is more sensitively designed and would lessen the impact of the proposals on the surrounding area and residents.

Please let me know how you would like to proceed.
