Proposal:
REAR GROUNDS: 1 x Beech (T720) - fell to ground level
1 x Beech (T139) - reduce crown by approx 3m in height, laterals by 1.5-2m

The Council has considered your application dated 10 May 2016 and decided to grant consent subject to the following condition(s):

Conditions and Reasons:

- 1 This decision is valid for 2 years from the date of this decision or until the work is completed, whichever is the sooner.

Reason: To allow the Council to monitor the completion and standards of the work.

- 2 All work shall be carried out in accordance with the relevant recommendations of



British Standard 3998: 2010. (Recommendation for Tree Work)

Reason: To ensure the preservation of the amenity value and health of the tree(s).

- 3 During the first available planting season following the completion of works, a *Fagus sylvatica* (common beech) tree shall be planted as a heavy standard with a girth size of 12-14cms, unless otherwise agreed in writing by the local authority. The tree shall be planted and maintained to the standards set out in BS8545:2014.


Reason: In order to comply with the provisions of Section 206 of the Town and Country Planning Act 1990 (as amended).
