E.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with 1 standard ash in the same place.

Rear Garden:

Group of Eucalyptus: Approximately 8.00m. Remove the eucalyptus to the rear left of the group and reduce the height of the remaining trees by 40-50%, prune back from boundary wall to clear by 1.00m. Reasons: They are fast growing trees and regular maintenance is warranted to ensure they are kept at a reasonable size for their location.

Hazel: Located top right of bottom lawn. Reduce crown by 20% and thin crown by 20% in order to form a more compact crown and increase light levels.

Cupressus: This tree is growing within the crown of the adjacent oak tree. Fell to ground level in order to allow for balanced crown generation of the more prominent oak tree.

Oak: This young oak is carrying significant amount of dead wood. Remove dead wood throughout crown.

Holm Oak: This large specimen tree has grown significantly since the last prune. Reduce the crown back to previous reduction points, thin crown density by 25-30% and raise crown by approximately 3.00m. Reasons: increase light levels and help manage the tree at reasonable dimensions for its location.
