We believe that the evidence quite clearly proves that the property has comprised of 2 self-contained flats to the first floor for in excess of four years. There are no shared facilities whatsoever. Each unit is wholly self-contained with the full range of services required for day to day living. Section 171B(2) of the Town and Country Planning Act 1990 states that where there has been a breach of planning control comprising a change of use of any building to use as a single dwelling house, no enforcement action may be taken after the end of the period of four years beginning with the date of the breach. The breach in the case of Flats B + C, 50 Hemstal Road, London, NW6 2AJ took place prior to 05/08/2011. Each of the 2 single dwelling units created has thus been in existence for in excess of the requisite four year period.
