Reasons - the tree is ill-suited to the tight location between the boundary wall and the main house; it has developed from a seedling rather than having been planted and it may cause damage to the boundary wall and the adjacent footpath; the relatively young tree is dominated by the presence of larger better-quality trees in the immediate vicinity.
