This document has been compiled as a guide to the samples which will be submitted to London Borough of Camden as partial discharge of Planning Condition 2.

The Planning Condition 2:

Detailed drawings, or samples of materials as appropriate, in respect of the following, shall be submitted to and approved in writing by the local planning authority before the relevant part of the work is begun:

a) Details including sections at 1:10 of all windows (including jambs, head and cill), ventilation grills, external doors and gates;

b) Manufacturer's specification details of all facing materials (to be submitted to the Local Planning Authority) and samples of those materials (to be provided on site).

c) Details including sections of photovoltaic panels at roof level; The relevant part of the works shall be carried out in accordance with the details thus approved and all approved samples shall be retained on site during the course of the works.

Note that this document contains details and samples relating to the new crittal windows and repairs to the external facade.

The outstanding information: sectional drawing through the PV panels and sample of the new external louvres and gates to the substation, will be submitted by way of a separate document as soon as the design is coordinated with the relevant subcontractors.




THE WINDOW DRAWINGS PROPOSED ELEVATION KEY


THE WINDOW DRAWINGS TYPICAL 3RD / 4TH FLOOR WINDOW ELEVATIONS 4W.08, 4W.09






