## TREE LIST APPLICATION for WEST HILL PARK

1. Line opp. no 24. Remove by & lift to 6m. to reduce shade & pollution drop on cars.
2. Scarlet Oak in lawn lift to 5m. remove dead wood. Reduce 2 x 3 in diam. branches at top towards East by 50%. (T.V. dish direction)
3. Mimosa in lawn. Trim down new top growth and shape
4. Evergreen oak & holly in woodland path. Lift to 4m, as before
5. Sycamore at bottom of garage of Hill Court. Remove 3 branches overhanging new house garden
6. Evergreen oak (near above). Lift over <sup>highgate</sup> west Hill to statutory height & remove 3 inside dying stems
7. Ash (adjoining) leaning at 45 degree. Fell
8. 3 dying hollies beside Hill Court. Remove
9. Yew near top of drive. Lift to 5 1/2 m.
10. Dead Pyracantha at no 7. Fell
11. Laurel under blue cedar opp no 27. Remove 1/2 over car park
12. Blue Cedar. Remove 3 broken branches. Shorten from light, over drive and over lawn by 3m.


