Furthermore, it is important to highlight that this planning application entails only permission to place the poles on public land and these poles reflect a planning matter and in no way reflect on the council's stance vis-a-vis religion or religious activities. This is an important distinction. Finally, to re-emphasize, an eruv has already been approved by various councils throughout the UK (and all over the world) and this application simply asks you to uphold the same in the best interest of the community.</p> <p>Secondly, as it has already been the case in other areas where an eruv is already in place, the eruv will allow for the expansion of community activities and for participation by many parties - particularly the elderly, families with small children, and those wheelchair bound - in these activities without the infringement of shabbath laws.
