Having these poles (and therefore the eruv) means that we would be able to go out on shabbat, to visit friends and the neighbourhood. Other areas of London, and many other cities in the world have eruvim (such as New York, Manchester, Johannesburg and Cape Town, cities in Israel such as Jerusalem and Tel Aviv). They are not noticeable or disruptive to non-Jewish residents and visitors, but make an immeasurable difference and improvement to the life of members of the Jewish community, such as those with young children or those who are less able to move around.

I have two young children and require the use of a buggy to get them to synagogue, family and friends and of course the Primrose Hill Park and playground areas, but as an observant Jew I cannot push them outside on the Sabbath. This therefore means that we are not able to engage as a family with our community, family and friends on days when it is most preferable to do so. Also being able to take children to the parks and playgrounds in the area is prohibitive because of distance without a buggy on the Sabbath. Indeed those with very young babies who cannot walk at all have no option to get out of the house with them on the Sabbath.</p> <p>I know of a number of elderly people who would also like to socialise and attend synagogue on the Sabbath but cannot because they are unable to carry walking aids or use wheelchairs due to the restrictions of carrying on the Jewish Sabbath. This can therefore make those elderly people feel more isolated and not feel like they are active members of the community, especially on the important days like the Sabbath.</p> <p>Having seen the plans and also seeing how other eruvim in many other areas in London have been constructed, I understand they will be carefully sited and designed and specified in a way that will minimise disruption to those living nearby. In many cases the subtlety of the thin poles and wire used is often not even noticeable by passers-by even when they are looking for it. I therefore think that with careful attention they will not pose any impact to those living nearby to those 13 sites and also no impact to nearby traffic or animal life.</p> <p>I would also like to reiterate that Camden is one of the only boroughs that do not currently have an Eruv built. There have been successful Eruvim (plural of Eruv) in Borehamwood, Bushey, Mill Hill, Edgware and others for many years and do not affect those who live by them whatsoever.</p> <p>I would like to thank Camden Council planners and councillors for spending time considering this application and would urge you to consider that the huge benefits for observant Jews in the area would massively outweigh any minor inconvenience for those not using it in them being built very subtly.</p> <p>Many thanks.
