Neil,

I'm conscious that it's coming up for two weeks since we spoke. You mentioned then that Catherine Bond was giving further consideration to the scheme.

Since Catherine hasn't been involved in any discussions to date we thought it would be helpful to provide a summary note in relation to built heritage. This has been sent to the case officer, who we trust will send it on to Catherine. We have also sent on a copy of the initial heritage research document from November 2014 – this informed the pre application process. It wasn't part of the application pack, so we're not aware of whether it has been seen by Catherine. If not, then we trust she will be able to look through it asap.

As you would expect, we are keen to move matters on. Could we please repeat our request for an opportunity to meet with Catherine. Having met both previous design/conservation officers dealing with the scheme, we do reasonably wish to speak with the third. (Although we won't of course need to take up time in further meetings if officers confirm the earlier position of support for the scheme.)
