The demolition relates largely to the rear extension part of the property - modern 21st century fabric including: internal walls, Floors, roof structure, all behind the historic facade, which is to be retained. Please refer to drawings 050A, 051A, 052A, 053A, 054A

The building does not function as a residential property in its current form. The extension to the property works against the main property in terms of circulation and flow. It appears to have been designed as two different properties, knocked through as an afterthought. Our proposal seeks to address these issues making the property function as a single-family home and reunifying the extension back to the main property.
