Proposal:

(TPO REF. 8H-T37) SIDE GARDEN: Chestnut, Lift to 6m, reduce back to clear building and street light 2m, Crown thin density by 20%, remove deadwood and tidy snag ends. (TPO REF. 8H-T36) FRONT GARDEN: Lime, Shape ends where necessary, cut no more than 2m - diameter maximum 1.5 inches. Clean through by 10%, lift road side to 5m for Bus clearance. Remove deadwood. No height reduction, maintain form of tree

The Council has considered your application dated 07 June 2016 and decided to grant consent subject to the following condition(s):

Conditions and Reasons:

Reason: To allow the Council to monitor the completion and standards of the
