T1 Ash (Twin Stem)

Works- REMOVE

Reason- The subject property is suffering damage identified by engineers as being due to clay shrinkage subsidence and the above trees have been recommended for removal to restore stability. Site investigations and soil test results have confirmed a plastic clay subsoil of very high volume change potential (NHBC Classification) susceptible to undergoing volumetric change in relation to changes in soil moisture. A comparison between moisture content and the plastic and liquid limits shows desiccation in BH1 which is corroborated by the suction values indicating very severe desiccation (BRE Digest 412). Roots were observed to a depth of 2600mm bgl in BH1 and recovered samples have been positively identified (using anatomical analysis) as ash, the origin of which will be T1 confirming the influence of this tree on the soils below the foundations. Consideration has been given to pruning as a means of mitigating the vegetative influence, however in this case, this is not considered to offer a viable long term solution due to the proximity of the responsible vegetation.
