The tree is a London plane.

The tree has been pollarded several times in its life. I am proposing to re-pollard it back to the second to last time it was pollarded some 4-5 meters around 30-35% crown reduction. The tree is very large for the space in the garden and some branches touch the surrounding buildings. It will also improve light quality to neighbouring houses.
