The proposed modifications will leave both buildings unaffected by the change.  
There are no structural modifications needed for this change, the roofs are unchanged. Existing supports will be reused for the new plant.

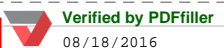

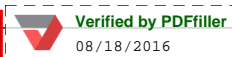
