Reinstatement / Restoration notes:

Wall panelling, plasterwork and timber detailing to be carefully restored according to JHA general statement of restoration works. Floorboards to be numbered, carefully refurbished and returned to original rooms. Windows to be upgraded to meet acoustic and thermal requirements, being retained and refurbished as far as possible. Fireplaces to be carefully restored. Heating to be provided using underfloor heating supplemented by trench heaters and/or radiators. Cooling to bedrooms to be provided by fan coil units in items of free standing fixed furniture.
