- T2, Robinia adjacent to neighbours property to be cut back and reduced due to squirrels nesting in roof.
- T3, Yew tree in neighbouring garden to the right to be trimmed to keep its shape
- T4, Large Robinia has major decay and trunk rot reduction on limbs to prolong trees life.

Front garden

- T5, Robinia between the 2 property's on Heathside to be reduced by 25% to bring the tree off the buildings and make a nice shape.
- T6, Hawthorn at front of driveway slight reduction and tidy up of dead wood.
- T7, Mulberry Tree at front of driveway slight reduction and one limb is overweight so to be reduced back into shape.
- T8, Scotch Pine thinning, removal of dead wood, overweight limbs to be reduced
