We live opposite the hotel and our window looks out onto the roof of the hotel. The proposed air handling units will have no acoustic shielding on our side of the hotel, therefore we will experience significant noise disturbance from installation and ongoing running of the air handling units. The applicants seem to have ignored the fact that their neighbours are a residential block. I am also concerned about the lack of privacy and disturbance caused by workmen on the roof of the hotel both during the installation period, and for maintenance etc as my flat will be directly visible from the roof. I urge the committee to reject this application.</p> <p>I have already objected to this application once, and understand that the proposal has been revised. The revised plans (which I did not receive notice of, despite my previous objections) take no account of my original concerns and the fundamental issue of noise disturbance to residential neighbours. I have wider concerns that the Planning Committee have not followed due process in this case by notifying those who objected about the revised plans.</p>
