Rear closet wing (1960 estimated), previously altered coal holes (1980), original coal hole (1845). Please refer to architectural drawings submitted as part of this application for further information.

Why is it necessary to demolish or extend (as applicable) all or part of the building(s) and or structure(s)?

The rear closet wing is uninsulated and suffers from water ingress. Reconstruction (at a shallower depth) allows greater light to the LGF accommodation, responds to the depth of the neighbouring rear projections, and allows a more ordered layout at GF. The previously altered coal holes suffer from water ingress and are uninhabitable. Extending the coal holes allows for a bedroom and en-suite accommodation to the LGF flat.
