E.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with 1 standard ash in the same place.

- 1 Bay Front, centre right Very large mature tree. To contain spread and improve light to and clearance of No 8. Reduce crown all round by up to 1m by shearing up, retain greenery. Lift low canopy over the lawn by 1-2m and level off 'browse line' all round. Clean out crown, remove deadwood and sucker.
- 2 False Acacia Very large mature very tall and widespreading tree. Not maintained ever, it would seem. very much more in need of remedial works to make safe than the somewhat less vital proposed works to the Bay tree. Suggest: To contain spread and lessen weight on branch ends of the very awkward and heavy lateral limbs all round and so maintain structural integrity and safety: Reduce and reshape crown by 30-35% all round to suitable new growing points. Thin and clean out crown, remove deadwood, weak and suppressed branches and sucker regrowth. Lift canopy all round by up to 2m and balance crown. These are works that really need addressing to pre-empt a potential limb-shedding incident
