Cherry: Approximately 8.00-9.00m. Fell to ground level. This tree has unfortunately suffered major and extensive crown dieback. The tree is unlikely to recover.

Lime: Storm damaged. 11.00m. This tree is showing strong regeneration. Thin re-growth by approximately 30-40% selecting strongest shoots for retention to create a new more natural open crown structure.

Holly: Approximately 4.00m. Located in boundary with Croft Way. Reduce height by approximately 1.00m to control.

Front Garden:

Mixed Hedge: Approximately 3.00-3.50m. Reduce to approximately 2.00m to allow hedge to re-generate and re-thicken.
