Previously on a cyclical re-pollard but tree has outgrown it's location to an extent that this no longer remains a viable maintenance procedure. Client would ultimately like to remove the tree due to damage to house and wall and is seeking advice on a obtaining report from a building surveyor. Please take this into consideration as a future option.
