Hi Nick

I hope you are well.

I have had some comments back from a senior officer on this who had a look through the application following the recent site visits. Unfortunately the proposal will not be supported by the council.

Unfortunately the existing extension is already not policy compliant (in that it's a rear extension which is higher than 1 storey below the eaves), therefore the current proposal would extend it up to the roof and create a large and bulky addition to the building further highlighting the negative impact of the previously added rear extension. Also in looking at the surrounding buildings they are also relatively unaltered at roof level.

The terrace/screening at 47 Ornan Road isn't really a good precedent as it's a different building type, and is actually an example of bad development which probably shouldn't have been approved therefore it would only hold a negative significance in relation to the current proposal.

Finally the current proposal would only serve to exacerbate the negative impact of the existing rear extension.

We will therefore be recommending refusal of the scheme.

Going forward you may want to proceed with the refusal and appeal the decision or withdraw the application as it is to be refused with no satisfactory solution presenting itself.

I hope this makes sense , please discuss with your client which route you would like to take and let me know.
