Dear Sir/Madam,

Firstly I would like to make a complaint of how we have been notified about this planning application. We had no idea this was happening and have not received any literature regarding this. The notice was only put up yesterday (12th September). I am sure of this as it is outside our front door. This has not given any of the residents any reasonable chance to make a complaint.

We reside in the flat above 186 Fordwych Road. As such any extension at the back of the property will negatively affect us as our bedroom will be directly above the proposed extension. The extension will be overlooked by a number of properties, which will undoubtedly lead to a loss of privacy. If it is a kitchen extension, the noise and cooking smells will negatively affect our living conditions. Similar properties have pitched roof single story extensions which will come very close to our bedroom window affecting our outlook on once a pleasant garden.

I strongly believe that the addition of an extension on the back of 186 Fordwych Rd will have a negative impact to the surrounding properties and will detrimentally affect the character of the building.

I would like this comment to be noted. I would also like this complaint of the notification period to be addressed. It is not acceptable that this notice appeared on the day of the deadline.
