Proposal:

To install a Seven Dials Trust People's Plaque commemorating the site of the workshop of barrow-making firm of Ellen Keeley (est. in Ireland in 1830). . Drawing Nos: Location Plan, Design & Access Statement, Photograph of Plaque Location, Example of Plaque, Positions Visual

The Council has considered your application and decided to grant Listed Building Consent subject to the following condition(s):

Conditions And Reasons:

1 The works hereby permitted shall be begun not later than the end of three years from the date of this consent.

Reason: In order to comply with the provisions of Section 18 of the Planning (Listed Buildings and Conservation Areas) Act 1990.

2 The works hereby approved are only those specifically indicated on the drawing(s)



referred to above.

Reason: In order to safeguard the special architectural and historic interest of the building in accordance with the requirements of policy CS14 of the London Borough of Camden Local Development Framework Core Strategy and policy DP25 of the London Borough of Camden Local Development Framework Development Policies.

3 All new work and work of making good shall be carried out to match the original work as closely as possible in materials and detailed execution.

Reason: In order to safeguard the special architectural and historic interest of the building in accordance with the requirements of policy CS14 of the London Borough of Camden Local Development Framework Core Strategy and policy DP25 of the London Borough of Camden Local Development Framework Development Policies.

Informative(s):

1 Reasons for granting listed building consent:

The site is a grade II and a terraced house and shop built in the early 18th century and restored in the early 19th century, it is constructed from yellow stock brick of four storeys with a basement, 2 window range and a 20th century shopfront. The proposal involves the addition of a 458 x 418 plaque, of vitreous grade steel flat plate, enamelled, and screen printed in four colours. It will follow the standard design and layout for the Seven Dials Trust's People's Plaques and will commemorate the site of the workshop of barrow -making firm of Ellen Keeley est. in Ireland in 1820.

The proposed plaque is sensitively located and has been designed to complement the existing design and materials of the building, and will match other plaques seen within this area. The proposed development is therefore considered to preserve the appearance, and hence the special interest of the grade II listed building.

Public consultation was undertaken by placement of a press notice and site notice. One response was received from the Covent Garden Community Association, who raised no objection. The site's planning history was taken into account when coming to this decision.

Special regard has been attached to the desirability of preserving the listed building and its features of special architectural or historic interest, under s.16 of the Listed Buildings and Conservation Areas Act 1990 as amended by the Enterprise and Regulatory Reform Act (ERR) 2013.

As such, the proposal is in general accordance with policy CS14 of the London Borough of Camden Local Development Framework Core Strategy, and policy DP25 of the London Borough of Camden Local Development Framework Development Policies. The proposed development also accords with policy 7.8 of the London Plan 2016, and paragraphs 14, 17, 56-68 and 126-141 of the National Planning Policy Framework.
