Installation of photovoltaic cells onto the roof of the SOAS Old College (Holden) Building.

Condition(s) and Reason(s):

The development hereby permitted must be begun not later than the end of three years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).



2 All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy CS14 of the London Borough of Camden Local Development Framework Core Strategy and policies DP24 and DP25 of the London Borough of Camden Local Development Framework Development Policies.

The development hereby permitted shall be carried out in accordance with the following approved plans: 5150627.001, 5150627.002, 5150627.003, 5150627.004, 5150627.005, 5150627.006, 5150627.007, 5150627.008, 5150627.009, 5150627.010, 5150627.011, 5150627.012 and Heritage, Design and Access Statement dated 25th July 2016.

Reason:

For the avoidance of doubt and in the interest of proper planning.

Informative(s):

1 Reasons for granting permission:

The proposed solar panels are considered acceptable in this rooftop location. They would not be visible in the immediate streetscene, or from longer views surrounding the application building due to the existing high parapet wall. Although there would be very limited views of the solar panels from the upper windows of neighbouring buildings, the visual impact is considered negligible due to their slim profile and dark colour which would help them to blend in with the roof. The overall impact of the panels would be minimal and the significance of the listed building would not be harmed, nor the character and appearance of the wider Bloomsbury Conservation Area.

Due to the location and nature of the proposals, they are not considered to significantly harm the amenity of neighbouring residential occupiers in terms of loss of light, privacy or daylight.

No objections have been received prior to making this decision. The site's planning history has been taken into account when coming to this decision.

Special regard has been attached to the desirability of preserving the listed building or its setting or any features of special architectural or historic interest which it possesses under s.66 of the Planning (Listed Buildings and Conservation Areas) Act 1990 as amended by the Enterprise and Regulatory Reform Act [ERR] 2013.

Special attention has been paid to the desirability of preserving or enhancing the character or appearance of the conservation area, under s.72 of the Planning

(Listed Buildings and Conservation Areas) Act 1990 as amended by the Enterprise and Regulatory Reform Act [ERR] 2013.

As such, the proposed development is in general accordance with policies CS5 and CS14 of the London Borough of Camden Local Development Framework Core Strategy, and policies DP24, DP25, and DP26 of the London Borough of Camden Local Development Framework Development Policies. The proposed development also accords with the London Plan 2016; and the National Planning Policy Framework 2012.
