Replacement tree approximately 3-4m Height, x 3-4m Width.

Silver Birch (T2) - fell because of low quality and value. Category and sub category grading BS5837 C2. To be replaced on the upper lawn area with a suitable alternative dependent on availability of suitable size, possible species to include: Amelanchier lamarckii, Magnolia species (M. x loebneri), Cornus Kousa or Prunus Yeodensis / Avium. Replacement tree approximately 3-4m Height, x 3-4m Width.

Myrobalan Plum (T4) - to be crown thinned by 20% of damaged, crossing branches and removal of climbing plants within canopy.
