Reduce height by 2.5 metres and trim face on garden side as high as possible retaining healthy growth, remove lower branches growing towards seating area.

Reduce the length of all branches by the removal of up to 1 metre in branch length in crown height and width and shape to balance.

- The proposed works would not reduce the amenity value of the tree and will allow sustainable tree management in the long term
