I know the government is putting the pressure on telecommunication companies to get base stations so then they can add more masts to it, but Troyes House is really not the ideal location for these telephone masts. If it is essential that this area needs more coverage, I am sure there must be more suitable sites away from residents. New child cancer statistics rate going up 40% in 16 years, this information was published just last month. In 2011 World Health Organization announced cell phones can possibly cause cancer, but before this announcement WHO assured people that no health effects had been established. So overnight they changed their minds, as they could do with a base station. So many people have died of cancer living near masts that I do not want to be used as a statistic in research. Even the Stewart Report which the government sponsored clearly does not rule out the possible harmful effects of exposure to low level electromagnetic fields, and recommends a precautionary approach when sitting these masts, so placing a base station 4 meters from my front door is not a precautionary approach.
